

OccAsianZ Venue Finding Terms and Conditions

By submitting the venue finder enquiry form, you are entering into an agreement with OccAsianZ Ltd. Registered in England no. 05027604 whose registered office is at 5 Jupiter House, Calleva Park, Aldermaston, Berkshire, RG7 8NN on the venue finder terms and conditions set out below.

General

- 1. Subject to the OccAsianZ working schedule and availability, OccAsianZ Ltd agrees not to charge the Client for sourcing the venue for the proposed event.
- 2. If the Client wishes to proceed with any of the proposed venue selections, the client agrees to engage OccAsianZ Ltd to act as the sole booking agent
- 3. OccAsianZ agrees not apply a mark-up to the published venue hire price.
- 4. The Client agrees not to book any of the proposed venues without notifying and engaging OccAsianZ Ltd. Should the client use any of the proposed venues without engaging OccAsianZ, OccAsianZ reserves the right to charge the Client for reasonable administrative charges, expenses and fees of up to 10% of the value of the proposed venue hire charge.
- 5. It is the Client's responsibility to check and ensure that all venue-booking details are accurate and correct. OccAsianZ Ltd accepts no responsibility or liability for any discrepancies discovered subsequent to the booking being confirmed.
- 6. All venue contracts are between the venue being booked and the Client and not with OccAsianZ Ltd.
- 7. When you submit your venue finder enquiry form, you are authorising OccAsianZ Ltd to disclosure your details to venues and third parties in order to fulfil your request.

Limitation of Liability

If a venue-finding fee has been applied / charged, OccAsianZ's liability to you is limited to refunding the price of the venue-finding fee only. OccAsianZ Ltd is not responsible to you to any greater extent and in particular is not liable to you for any indirect or consequential loss (including without limitation financial loss such as loss of profit or otherwise) that you may incur as a consequence of its failure to comply with these venue finding terms and conditions.

For the avoidance of doubt nothing in these venue finder terms and conditions shall serve to exclude or limit OccAsianZ Ltd liability in respect of death or personal injury caused by OccAsianZ Ltd negligence or the negligence of its officers or employees.
